| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include: |

Social Security number and IncomeAccount Balances and Loan Balances

Account Transactions and Payment History

When you are *no longer* our customer, we continue to share your information as described in this notice.

All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information; the reasons Memorial Federal CU chooses to share; and whether you can limit this sharing.
